

Terms and Conditions of Entry

The prizes and how to enter:

NZCU STEELSANDS is the Promoter (“the Promoter”).

1. The promotional period begins on Friday 26 July, 2019 and finishes on Monday 26 August, 2019. All prizes will be drawn on 28 August, 2019.

2. Customer must be a current AccessDebit Mastercard® Holder and hold a valid AccessDebit Mastercard issued in New Zealand.

3. Enter the draw to win a Double package (2 Tickets) to a 5 Day Priceless Experience, courtesy of Mastercard, for New Zealand v South Africa match on 21 September, 2019 in Japan at Rugby World Cup 2019™ when you make any purchase using your AccessDebit Mastercard.

6. Only transactions on AccessDebit Mastercard’s must be conducted online or contactless to be eligible. Payments using domestic EFTPOS do not qualify for this promotion.

7. To enter the competition you must, during the promotional period:

a. Use your AccessDebit Mastercard for domestic or international transactions

and

b. Pay for the transaction with a valid AccessDebit Mastercard

8. Each transaction automatically goes into the prize draw.

12. Winners will be contacted by 30 August, 2019 by their Credit Union between the hours of 9am and 5pm.

13. **NZCU STEELSANDS** will validate the transaction and will advise Mastercard of the winning transaction details in order for the winner to redeem their prize.

14. The winner has 14 days to respond to the notification from the **NZCU STEELSANDS** that they have won the Prize, after which time **NZCU STEELSANDS** and Mastercard have the discretion to redraw and award the Prize to another winner chosen at random from all valid entries submitted during the Promotion Period.

Further each winner and his/her guest(s) acknowledge that he/she may be required to enter into a direct acknowledgement and/or agreement with RWCL and/or JR2019 concerning use of the tickets and compliance with ticket terms and conditions prior to receiving the prize.
